C: Ilisa Stalberg, Vermont Department of Health: Important to note that the Sample policy is recommended for schools to adopt, but is at the discretion of districts.

Q: Is Day 0 still onset of symptoms rather than date of positive test?

A: *Breena Holmes, MD, VCHIP: YES, onset of symptoms if day 0.*

Testing Supplies

Q: Are we going to get supplies of tests for next year as well?

A: *Ilisa Stalberg, Vermont Department of Health: We don't yet know.*

Boosters for 5-11 year olds

Q: Are children 5-11 y/o going to receive a booster after 5 months?

A: *Monica Ogelby, Vermont Department of Health: Boosters not approved for 5-11 yet.*

EMS Support

C: I have heard concerns that EMS vax/test clinics are negatively impacting EMS availability for patient transports, one more reason to continue to migrate testing/vax to PCP offices and pharmacies.

C: Monica Ogelby, Vermont Department of Health: (verbally): We will maintain EMS and VT National Guard to support the infrastructure that we shared. Though we will not be standing up mass clinics at the Double Tree of Berlin Mall, they will still be available to help with place-based or work-based or school-based clinics, we'll still be able to support those clinics as needed.

C: Good call. We are seeing EMS crews stretched very thin throughout the state with transport of patients.
