

## KENNETH AND BESSIE LADEAU TRUST FUND INFORMATION

The Kenneth and Bessie Ladeau Trust Fund was established according to Article Eighth of the Last Will and Testament of Bessie Ladeau.

The Trust was established with the following criteria, preference given in the order as set forth below:

- 1)"To aid a resident of Vermont who is a medical student and is enrolled in his/her last two years of medical school or for a year thereafter, or for all three years, who specializes in the treatment of heart ailments or cancer, whether said student be attending a medical school in Vermont or elsewhere, providing that he/she is in need of financial assistance.
- 2)To such a student or graduate not specializing in heart ailments or cancer, but in some other medical or surgical field.
- 3)To such a student or graduate from New Hampshire, if no Vermont resident qualifies in the sole discretion of the Trustees, for any year.
- 4)If in any year, none qualify, in the sole discretion of the Trustees, income is to be added to the corpus of the Trust and used for said purposes in the following years, as the need arises."

Amounts are discretionary, and have generally ranged from \$1,000.00 to \$6,000.00

All applications must be received no later than April 30th.

Whenever possible, applicants will be personally interviewed by the Trustee.
