





VDH COVID-19 Vaccine Dashboard








Total Doses Administered per 100,000

VDH Update: New Symptoms Post-COVID Infection

I have recovered from COVID-19, but I am sick with a new illness and symptoms. When can I return to work, school or child care? #

Last Updated: Feb 4

If you develop new illness symptoms within the first 3 months of recovering from a COVID-19 infection, we do not recommend retesting. Data to date show that a person who has had and recovered from COVID-19 may have low levels of virus in their bodies for up to 3 months after diagnosis. This means that if the person who has recovered from COVID-19 is retested within 3 months of their initial infection, they may continue to have a positive test result, even though they are not spreading COVID-19.

You should still stay home when you are sick to prevent spreading illness to others. You should remain home until your symptoms have improved or are gone. If you have a fever, you should stay home until you are fever-free (without the use of fever-reducing medicine) for at least 24 hours. Contact your health care provider if you have questions or concerns.

Learn more about <u>if people who recover from COVID-19 can be infected again</u> and <u>when</u> you are considered to be recovered from COVID-19.

VDH Update: Quarantine

I had COVID-19. Do I need to quarantine if I am a close contact of someone with COVID-19?

Last Updated: Feb 4

If you had COVID-19 – and then are exposed to someone with COVID-19 (for example, you are a close contact of someone with COVID-19) – **you do not need to quarantine only if**:

- 1. you had a positive COVID-19 test result (from a PCR or antigen test) and have met the criteria to end your isolation, and
- the new exposure is within the first 3 months <u>after symptoms from your initial</u> <u>infection started</u>, or within the first 3 months of your <u>first positive test if you didn't</u> <u>have symptoms</u> during your initial infection, **and**
- 3. you have not had any COVID-19 symptoms since the new exposure.

However, **you must quarantine** when you travel or return to Vermont under the <u>current</u> <u>travel guidelines</u> and **you are not allowed to gather** with people you don't live with under the <u>current social gathering guidelines</u>.

Friday Media Briefing (2/5/21)

Governor Phil Scott

- Many looking forward to return of competition for certain school/youth sports; our approach has been among most cautious in U.S. – will now allow competition w/safety GLs.
- Halloween gathering had major impact on spread of virus;
 please follow gathering guidance for Super Bowl.
 - Multi-household gatherings are still not allowed.
 - To parents: don't ruin this for your kids.
- As of yesterday: >10% eligible Vermonters have received first dose vaccine; supply to increase & J & J seeking approval.
- Anticipate opening registration to next group before end Feb.







Friday Media Briefing

AOE Secretary French



- Weekly PCR testing in schools update next week due to schedule change this week (snowstorm: moved Tuesday testing to Thursday)
- VPA Survey: "How are your students doing academically?"
- □ 58 principals responded range of outcomes: more students struggling, not passing courses, more substantially disengaged/at risk of dropping out; highachieving w/tremendously higher stress levels than normal.
 - Still working to close gaps from remote learning in spring; absenteeism/lack of engagement are central concerns.
 - Handful (elected remote 5d./wk.) rarely attend nor respond to outreach; some groups maintaining acad. achievement levels despite challenges. Genl. disposition much more passive – class conversations more subdued; few field experiences.

Friday Media Briefing

- Agency of Natural Resources Secretary Julie Moore
- □ Feb. 12: resume interscholastic/youth competition
- Basketball, hockey, indoor soccer, futsal, broomball, volleyball.
- Indiv. sports/low-no contact: swimming, bowling, figure skating, dance, gymnastics.
- Close proximity sports: no more than 2 games/7d. & minimum 3d. between games. No spectators at indoor events – only key personnel.
- □ Enc. look for creative solutions e.g., virtual viewing.
- □ Updated guidance on SOV web site by end of day Monday, 2/8/21
- Mask mandate extended to referees & officials or indoor sports events.
- No evidence of virus exposure as result of last phases past 2 ½ wks, close
 Contacts w/in teams but no evidence of transmission.

AHS Secretary Mike Smith

- 58,219 Vaccine update: 21% in 75+ have rec'd. 1st dose; 33,100 have registered.
- □ This week added Alburgh, Beecher Falls (Essex Co.)
- □ Next week: Grace Cottage; NMC; week after Mt. Ascutney Hosp.
- Last night clinic for those w/ltd. English prof in BTV 50; this eve., Winooski for 50 (75+)
- Recent final CDC guidance transporting vaccine for homebound.
 - Today: Caledonia, Franklin, Orange, Windsor, Windham Counties
- □ Partnership between local HHA & EMS HHA will contact clients
 - Ongoing discussion re: outreach to non-clients.







AHS Secretary Mike Smith

- Group 1a continue to be eligible hospitals continue to receive vaccine if appts. were delayed or earlier choice not to receive; & for new employees. No new categories added to Group 1a.
 - Register via hospital NOT online; latter ONLY for Vermonters 75+.
 - In regular communication with hospitals, including est. numbers needed (~2500).
- □ Will be some overlap as transition from one group to next.
- □ Please recall: **NO waiting list** for "extra doses at end of day."
- Striving to prevent wasted doses by we have list of registered 75+ in each areas and those eligible in 1a & homebound we will call them.
 <u>Last resort</u>: local clinics may give to non-eligible to prevent waste.









Friday Media Briefing (cont'd.)

VDH Commissioner Levine

- □ Our 7-day case numbers trending down: 7d. average low 130s.
- Continuing to monitor increased spread in Bennington Co.
- Increased testing: northern half of Benn. Co.; engaging ski areas. Goal: all residents have ready access to testing.
- This could occur anywhere in VT began w/multi-HH gatherings in Dec. May reflect NY proximity, ski. But majority reflects community transmission.
- □ SVMC hospitalizations have stabilized; regional hospitals collaborating.
- □ Continuing efforts re: genetic sequencing expect 1st results early next wk.
- □ B.1.1.7 now detected in 33 states- expect to see in VT.
- Deaths w/o increase today; trend improving; reflects LTCFs.









Friday Media Briefing (cont'd.)

VDH Commissioner Levine

- □ VDH report: 71% of LTCFs w/o outbreak or cases.
- Steep drop in incidence rate among staff/residents from Dec. Jan.
- More aggressive testing (BinaxNOW Ag tests) & successful vaccine program.
 - LTC residents account for >2/3 deaths in VT.
- \square 65% that had a single case did NOT see additional spread.
- □ Reflects work of VDH HC Outbreak Prevention & Response team/policies.
- Youth sports: current data reinforces these decisions does not disrupt inperson learning.
- □ "What worries me far more is a certain American tradition coming on Sun."







Friday Media Briefing (cont'd.)

VDH Commissioner Levine

- □ Super Bowl has potential to truly damage our recent progress.
- Stick to your own household gathering increases risk b/c indoors, eating/drinking w/o masks.
- □ SEE CDC tips (next slide)
- □ You might say, "how naïve he is...what harm could come from this now?"
- Recall: it was Halloween gatherings/parties that drove beginning of our uptick in cases 3 months ago; hasn't slowed down yet.
- End on optimistic note re: vaccine Oxford Astra-Zeneca has potential to slow transmission. New data very preliminary/not peer-reviewed.
 - Monitoring vaccinees: 67% reduction in pos. (PCR) nasal swabs between groups.





Calling All Football Fans

VDH: Watch the Super Bowl Safely

- □ Celebrate with the people you live with.
- Host a virtual watch party / start a text group
 & chat while you watch.
- Make your own game-day apps/snacks or get take-out food (support local food estab.)
- Remember: many VT cases/outbreaks started with small gatherings.
 - Dr. Fauci (ABC's "Good Morning America"): "You don't want parties with people that you haven't had much contact with. You just don't know if they're infected. So as difficult as that is, at least this time around, just lay low and cool it."

Safer Ways to Enjoy the Super Bowl

Gathering virtually or with the people you live with is the safest way to celebrate the Super Bowl this year. If you do have a small gathering with people who don't live with you, outdoors is safer than indoors. This year, choose a safer way to enjoy the game.



Host a virtual Super Bowl watch party.

- Wear clothing or decorate your home with your favorite team's logo or colors.
- Make appetizers or snacks with the people you live with to enjoy while watching the game and share the recipes with your friends and family.
- Start a text group with other fans to chat about the game while watching.

Attend an outdoor viewing party where viewers can sit 6 feet apart.

- Use a projector screen to broadcast the game.
- Sit at least 6 feet away from people you don't live with.
