





VDH – AOE Updates

- Request your input: With updated guidance for travel & testing requirement upon return, what is your capacity to test infants? Pop up sites do not test anyone less than 12 months of age.
 - If you do not test on site, do you refer to other health care sites?
- Official AOE clarification on quarantine: "schools may <u>not</u> implement policies that keep siblings of close contacts in quarantine at home, instead of allowing them to come to school."
- Clinical Q: mother of 1 month-old who is breastfeeding wishes to get COVID-19 vaccine; asked if <u>her</u> vaccination can interfere w/the infant's 2 mo. immunizations (does she need a 2 week window around the infant's immunizations). A: No interference or need for delay.













7-Day moving average



VDH Health Advisory – April 13, 2021

- Cases of Cerebral Venous Sinus Thrombosis w/Thrombocytopenia after Receipt of the Johnson & Johnson (J&J) Janssen COVID-19 Vaccine
- CDC & FDA joint statement (4/13/21); CDC health alert; ACIP meeting 4/14/21
- Requested Actions:
 - Be aware of the adverse events reported among recipients of the J&J Janssen COVID-19 vaccine. In patients with the appropriate clinical presentation, obtain a platelet count as initial screen for immune thrombotic thrombocytopenia.
 - Pause the use of the J&J Janssen COVID-19 vaccine until further notice. Continue administration of the available mRNA vaccines.
 - Be prepared to recognize and manage, in consultation with a specialist in hematology, these potential adverse events among persons who have received the J&J Janssen COVID-19 vaccine.
 - Report adverse events to the Vaccine Adverse Event Reporting System (VAERS).

Tuesday Media Briefing (4/13/21)

Governor Phil Scott

- Just off White House call w/Drs. Fauci, Walensky, etc.
- J & J vaccine "pause"; recommendation, not mandate, "out of abundance of caution" based on 6 cases/6.8m. vaccinated; "extremely rare."
- □ "Likely to be on pause for days, not weeks."
- VT will see ~same allocation as last week. No J & J this week but slight increase in Pfizer & Moderna for state and federal pharmacy programs.





AHS Secretary Mike Smith

- We have paused J & J thru Friday give feds time to carry out further study.
- Delays approx. 2K doses today, 2K more thru end of week; 1800 scheduled out further (determining what to do with those).
- Offering to reschedule those from this week for 2-dose vaccine OR receive J & J LATER if precautions lifted.
- Too early to assess impact right now on longer term vaccine strategy;
 we'll modify strategy/timeline if necessary moving forward.
- BIPOC population + household members: >6k have appts.





VDH Commissioner Levine

- Big news today: CDC/state actions regarding J & J vax. Unsettling news to some – until we know more, VTers who were scheduled for this vaccine will be rescheduled; call ctr. may have longer wait times.
- "Curious clinical syndrome blood clotting in atypical places at a time when platelet counts abnormally low." 6 cases being reviewed among women 16-48 y.o.; sxs developed 6-13 days after dose.
- CDC calling this a pause/"safety signal"; allows ACIP to meet.
 - Time to give HC community info they need re: treatment NOT traditional heparin.
- □ To date only a few reports of J & J reactions online tool (all benign).

No cases of blood clots in Vermont.





VDH Commissioner Levine

- Cases among younger VTers: you may have seen photos from North Beach this past weekend.
- Largely unmasked & not much physical distancing (probably not unique to Burlington).
- I want VTers to enjoy the outdoors safer than being inside & important for MH, but "disappointed to see such blatant disregard for the rules. This kind of behavior is just not OK right now. Everyone needs to remember we're all part of a larger community & need to protect one another."





VDH Commissioner Levine

Top 10 reasons to get vaccinated (especially for younger people):

- Just because you're young and healthy, doesn't mean that you can't get very sick from COVID-19, including needing hospitalization.
- There is still much we don't know about long haul COVID.
- If enough people don't get vaccinated, there will be more person-toperson transmission and more opportunity for new variants to emerge.
- We're all ready for a time with less anxiety and less uncertainty.
- Seeing friends and family.





VDH Commissioner Levine

Top 10 reasons to get vaccinated (cont'd.)

- Staying healthy means less missed work and less financial stress.
- Getting vaccinated means we won't have to miss out on school and college.
- Getting vaccinated means, you can protect yourself when you travel, especially when infection rates vary in different places.
- Incentives. There might be a cremee coupon at the vaccine site.
- Making this one decision will make a healthier future for all of us.

If you have a young person in your life, talk to them and help them find a reason to be vaccinated!





Modeling – Commissioner Pieciak:

- 7d. case rate down; cases down in almost every age category (greatest decrease in 20-29 yo down 11% over past week). But that age grp. continues w/disproportionately high case rates vs. their portion of population.
- Weekly testing #s: for past 30d. VT leads US in per capita testing Northeast also v. high.
- Cases in NEK higher; but Rutland & Chittenden improving.
- Forecast late March: track closely for 1st 7-10d.; then trajectory changed ~1 wk. ago for better. Wyman model: cases relatively flat in short term, then decrease in later April, into May.
- Regional: Northeast cases stabilized this week, down ~1%. NY, MA, CT improved while NH & ME seeing cases continue to rise.

Advancing Child Health

In 2021 for the future

Primary Care Sustainability

Urging the Senate Health and Welfare Committee to prioritize a portion of the State's one-time, federal funds for primary care:

- Payments: Increase the Medicaid RBRVS Fee Schedule to bring primary care codes to 105% of Medicare;
- Sustainability: Dedicate ARPA funds for primary care Innovation grants that can be used to fund practice transformation to alleviate administrative burden, add mental health services and move towards value-based care:
- Workforce: Support on-going investment into the new primary care scholarship program in H.439.

Despite being called a key priority, Vermont primary care has experienced a gradual erosion in Medicaid **payment**, including current cuts in the 2021 fee schedule, decreases in primary care case management fees and lower vaccine administration fees. Vermont primary care providers face an avalanche of administrative burden that is **unsustainable**, largely exacerbated by COVID-19 and efforts to transform practices to value-based care. The primary care **workforce** is at crisis-levels, with low reimbursement and non-competitive loan repayment making recruitment and retention extremely difficult.

Please tell lawmakers how these small reductions are adding up to impact your practice and that the restoration of this funding will help primary care practices survive during this critical time and that the primary care scholarship funding is critical to ensure Vermont's rural health care workforce.

Primary Care Sustainability

- Scholarship Funding
 - On-going appropriation for the primary care scholarship that was created by the legislature in 2020.
 - Scholarship program has not yet been implemented by AHEC. In response, the legislature is drafting an MOU between AHEC and the Vermont Student Assistance Corporation (VSAC) requiring collaboration to establish the scholarship program.
 - Medical school tuition for up to five third-year and five fourth-year medical students. Recipients must fulfill two-years of full-time service or four-years of half-time service for each academic year of tuition covered by the scholarship.

COVID-19 Emergency Flexibilities

- > Audio-Only Telehealth
 - For the remainder of 2021, health insurance companies regulated by the State of Vermont must reimburse for audioonly telehealth services at parity with in-person services; for insurance plan years 2022-2024 DFR, in consultation with stakeholders, will determine amounts for plans to pay
 - Consent will be required for audio-only telehealth services as soon as the bill goes into effect (before 3/31/21), so practices should begin to adopt an updated consent form and process immediately. VMS has a sample available here.

Signed by Governor

Expansion of Dr. Dynasaur

H.430 expands eligibility for Dr. Dynasaur by July 1, 2022 to all income-eligible children and pregnant women who would otherwise qualify for Medicaid except for their immigration status. AAPVT, VTAFP and VMS support this expansion and are part of a coalition pushing for this legislation to pass.

Passed the House and now in Senate Health & Welfare

Public Health

- Mixed Martial Arts and Children
 - Allow for more oversight and authority of the Office of Professional Regulation
 - History of MMA matches involving children
- > Flavor Ban on Tobacco Products
 - S.24 would ban the sale of flavored tobacco products including menthol products.
 - Passed Senate Health and Welfare and advanced to the Senate Economic Development, Housing and General Affairs Committee.

Public Health

- Cannabis Regulation
 - \$.25 was introduced as a "housekeeping" bill to meet some of the Governor's requests when he let \$.54 pass unsigned in 2020. The requests included additional marketing restrictions and safeguarding prevention funding.
 - The bill in its current form does meet some of the Governor's and VMS/AAPVT requests to protect the public health as much as possible
 - limit advertising to venues where not more than 15 percent of the audience is reasonably expected to be under the age of 21.
 - all advertisements contain health warnings and be approved by the Cannabis Control Board prior to dissemination.
 - Puts up "guard rails" on the prevention dollars to ensure that 30% of the revenue raised by the cannabis excise tax is used for the purpose of funding substance misuse prevention programming, even if carried over from a previous fiscal year.

Public Health

- Sales Tax Exemption for Feminine Hygiene Products
 - <u>S.53</u>, would provide an exemption from sales tax for feminine hygiene products.
 - > Passed the Senate unanimously and advanced to the House Ways and Means Committee

Injury Prevention

- > Firearm Safety
 - Prohibition on Possession of Firearms in Hospital Buildings
 - S.30 would make knowingly possessing a firearm in a hospital a criminal offense.
 - › Becca Bell, M.D. testified to the real and immediate need for this legislation, and was referred to and quoted by Senators when citing the need for passage.
 - > Passed Senate and now in House Judiciary
 - Extreme Relief From Abuse Orders Bill Passes the House
 - > H.133 would require any defendant issued a temporary relief from abuse order to immediately relinquish, until the expiration of the order, all firearms that are in the defendant's possession, ownership, or control, and to refrain from acquiring or possessing any firearms while the order is in effect.
 - Passed the House and now in Senate Judiciary

Summer Programs

- > Summer Matters Initiative
 - Vermont Afterschool, in partnership with the Vermont Agency of Education and Vermont Agency of Human Services, along with U.S. Senator Bernie Sanders' Office, recently coordinated Governor Phil Scott's and Senator Sanders' vision to provide expanded summer enrichment opportunities for youth statewide. The work we do this summer will meet the immediate needs of Vermont families and inform our collective efforts to provide universal afterschool in the future.
 - Three Key Messages
 - > Summer is important. Our kids need to be able to enjoy this summer and use it as a time to re-connect with their friends, family, and communities.
 - > Summer is safe. We can and will design guidelines and strategies to keep kids safe while they spend their time being kids.
 - > Summer programs are available. We are working with our partners to ensure that there are program options across the state that are accessible and affordable for families.

Early Childhood Education

- > Child Care Financing & Accessibility
 - <u>H.171</u> would
 - > (1) expand the eligibility of the Child Care Financial Assistance Program;
 - (2) appropriate funds for the implementation of the Bright Futures Information System modernization plan; (
 - 3) establish scholarships and student loan repayment assistance programs for existing and prospective members of the child care workforce;
 - (4) require the completion of studies on child care financing and governance; and
 - (5) establish an Early Care and Education Governance and Administration Advisory Committee.

Passed the House and is now in the Senate Health & Welfare Committee


