

- VT Cannabis Control Board appointed & being confirmed by Legislature; looming deadlines for decisions to be made right away.
  - Bill in legislature to tighten prevention funding language and add limitations to advertising sitting in House Govt. Ops. If doesn't pass will be up to board to come up with advertising plan to bring back to the legislature.
  - Bill would also mandate that towns hold a vote on allowing retail stores in their towns by 2023.







### **Schools:**

- □ SEE **Burlington Free Press** (4/18/21): "We've always been the good guys" VT School Nurses just had the most tiring year."
  - But positives: staff recognizing expertise; how well students adapted to protocols.
- Quiet weekend for school cases (school vacation last week for many)
- AHS group working with AOE to discontinue the teacher surveillance testing and move to voluntary student surveillance at beg. of May.
  - Anticipate pilot in a few communities who have asked/volunteered; hope to help inform any routine student surveillance testing planning for Fall 2020.







## VDH: Getting the COVID-19 Vaccine

### Special instructions for 16 & 17 year-olds:

- □ "You will only see appointments for the Pfizer vaccine, since that is the only vaccine that is authorized for people age 16 and 17.
- For the state appointment system and appointments made through CVS, your parent or guardian will need to review the consent forms and check the box giving their consent for you to get the vaccine. Your parent or guardian does not need to go with you to your appointment.
- □ Kinney and Walgreens require a parent or guardian to be present and give consent at the appointment."

# I'm 16 or 17. What do I need to know about getting my vaccine? (4/15/21)

- If you are making an appointment through VDH website, create an account.
   (youth or parent may create), or parent or guardian can add you as a dependent on their account.
- You will only see appointments for the Pfizer vaccine (only vaccine authorized for people age 16-17). May need to look at neighboring cos. if nothing in your co.
- Parent/guardian must review consent forms & check the box giving their consent.
   for you to get the vaccine. Consent built into the registration process, so parent/guardian does not need to accompany youth.
- If appt. directly through Kinney Drugs, CVS, Walgreens or Northfield Pharmacy, check their confirmation email for instructions re: consent from a parent/guardian and requirement to come with you to your appointment.

## VDH: Getting the COVID-19 Vaccine

### Special instructions for those who live another state:

- □ "You can still get a vaccine in Vermont if
  - You work in an occupation/setting in Vermont that is currently eligible.
  - You moved to Vermont w/in last 6 mos. w/intention of becoming a resident & are in age, occupation or another group currently eligible.
- April 30: VT expects to open registration to college students who are residents of another state & do <u>not</u> intend to stay in VT for the summer, <u>and</u> people who live part of the year in Vermont – will be based on the vaccine supply from the federal government."
  - □ Set up account now, so you'll be ready to make appt. when eligible.




### From the CDC Vaccine Tracker



### Coronavirus Vaccine News

- CDC reports almost 130 million people 18 or older (half of all adults) have received at least one dose of COVID-19 vaccine, or 50.4% of the total adult population. Almost 84 million adults (~32.5% of the pop.) are fully vaccinated.
- U.S. vaccination rate, at 61.6 doses administered per 100 people, currently falls behind Israel (leads among countries with at least 5 million people with a rate of 119.2 doses).
  - U.S. also trails the United Arab Emirates, Chile and the United Kingdom, which is vaccinating at a rate of 62 doses per 100 people, according to Our World in Data, an online research site.





## White House Coronavirus Briefing (4/19/21)

- □ Focus on all states/territories opening vaccine to 16+ today
- CDC Director Dr. Rochelle Walensky
  - Breakthrough infections: <6K / >84m. Fully vaccinated; 30% without symptoms.
  - SEE CDC re: how HCPs & PH officials may report breakthroughs.
- NIAID Director & White House Chief Medical Advisor Dr. Anthony Fauci – vaccines are:
  - Efficacious in clinical trials
  - Effective in real-world settings
  - Safe
  - Reviewed data that support above





## White House Briefing (cont'd.)

### **Q & A**

- Q: Rural urban divide? Walensky: CDC analyzing data right now at county & zip code level re: vaccine uptake & cases. Will share when available.
- Q: When vaccine demand uneven, will you change distribution strategy e.g., by pop., or by demand? Slavitt: We think supply adequate for all. Just because states may be behind/take more work to administer, shouldn't give up on those locations. We & state/county/local listen to community & provide info needed for vaccine decision. Walensky: we know distribution not uniform.
- Q: Any more severe adverse (thrombotic) events? Walensky: CDC & FDA collecting & working our way through VAERS reports to verify; "a handful, not an overwhelming number." Plan to present to ACIP Friday, 4/23/21.





## White House Briefing (cont'd.)

### **Q & A**

- □ Q: Will current vaccine pace (~3 3.5m. doses/day) increase? Slavitt: putting 28m. doses into field weekly, no number is high enough for us. Can't predict but prepared to sustain the pace. Today's the day: no longer a challenging process has never been easier.
- Q: After Biden's 100 days, do you anticipate lessening of mask requirement?
   Slavitt: let's get to the 100 days you know Pres. Biden follows the science & listens to scientists. 12d. to go: please mask up we know it does save lives.
- □ Q: more mile markers on highway back to normalcy? Is it your medical opinion masks will be advisable after 100d mark? Advice re: travel? Israel began to lift outdoor mask mandates at 60% vax rate what milestones should U.S. public expect? Fauci: U.S. 7d. average = 60-70K cases/d. Israel case level was extremely low when they did that. That's what we're aiming for. Slavitt: if
