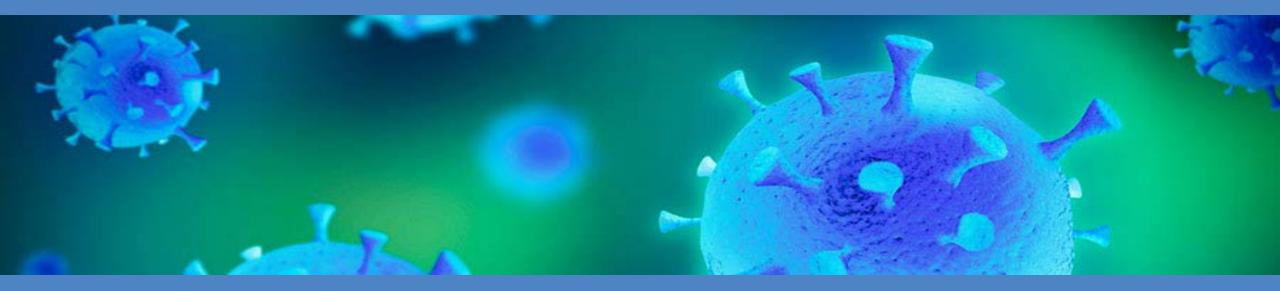

# Situation update





 VDH Public Health Lab 259 tests and UVMMC Lab 622 tests (5/26/20)

### Correction: 1 positive inpatient


Hospitalized patients: <u>zero</u> patients in ICU or on ventilator

As of May 16, the total testing numbers decreased by about 1,000 due to a change in reporting data. The "total tests" number no longer includes serology tests (also known as antibody tests) that were being reported by some labs. The "total test" number now only reflects people who were tested for a current COVID-19 infection.

Reminder: "Total People Recovered" based on the number of confirmed positive cases (VT residents & non-VT residents who tested positive in VT; does not include deaths or patients currently hospitalized).

 NEW HAN: Guidance on N95 Respirator Sterilization in Your Region (May 26, 2020)

- Implementing safe mitigation strategies to preserve N95 supply in a time of global shortage ("facilities and emergency services")
- References CDC optimization strategies & VDH occupational guidance
- 8 Vermont hospitals providing sterilization services (pt. of contact info provided)
- □ Testing continued discussion re: overall strategy (ant. nares testing)
- □ VMS call with Commissioner Levine (5/26/20):
  - New CMS guidance for long-term care (LTC) facilities
  - Possible provision of oximeters to newly-diagnosed (outpatient) cases

**3 large issues**: returning college students and plans for fall; child care; tourism

  - Children able to attend: healthy children . . . with allergy symptoms without a fever that cause coughing and *clear runny nose* may stay if they have medically diagnosed allergies and follow any medical treatment plans"

□ Anticipate VDH HAN: MIS-C (Multisystem Inflammatory Syndrome in Children)



### Update: Mother-Baby Care

- NNEPQIN continues to follow regional developments in mother-baby care
- Maine Medical Center now testing asymptomatic mothers prior to delivery
  - 1.7% pos. rate of asymptomatic mothers testing positive (N = 156)

# Today's Media Briefing

### Governor Scott:

- Continued monitoring of regional data; expected guidance:
  - Anticipate announcement Friday re: (e.g.) cleaning services & gyms; finalizing guidance for overnight camps; anticipate resumption indoor dining in not-too-distant future
- Since 5/24/20 (Sun.): NH w/240 new cases/43 deaths; MA w/2000 new cases/675 deaths; VT w/13 new cases/0 deaths.

### □ <u>Q & A</u>

- When might 2-week quarantine rule be lifted? Ans: determining benchmarks now
- Childcare concerns (Secy. Smith): we've consulted with VDH through Breena Holmes
- Plans announcement tomorrow re: seeking re-election?
- Concern re: increase in on-line sales by OOS buyers? Ans: no/but affordability issue)

# Today's Media Briefing

Commissioner Levine:

- Monitor ambient temperatures & take safety precautions
- Address news reports re: Vermont as one of "18 states in trouble"
  & one of "5 in highest degree of trouble" <u>data</u> dispels that notion:
  - □ We continue to flatten the curve: 971 cases, 54 deaths, 849 (est.) recovered
  - Reported # of new cases tech 50% increase but actual = 2 cases, 3 cases, >50% if 7 cases. But very few cases on a daily basis "minor gyrations in setting where we're doing hundreds and hundreds of tests per day"
  - Rate of new cases is "very, very, very small"
  - Test positivity rate hovering at < 1% for some time
  - Syndromic surveillance
- Now many more opportunities for asymptomatic testing
