



Vermont COVID-19 **New** and **Cumulative** Cases, **Cumulative** Deaths




COVID-19 Positive Cases by Sex

VDH/AHS Updates

STARTING TODAY (June 15), travelers have the option to:

- ❑ Quarantine in their home state for 14 days before coming to Vermont if driving in personal vehicle and making no stops along the way OR
- ❑ Quarantine at a Vermont lodging establishment for 14 days if making stops along the way or traveling by plane, train, bus or other means of transportation.

VDH Updates (cont'd.)

- **COVID-19 testing events in Burlington and Winooski, June 15 through June 19:**
 - ▣ **Who:** Anyone **without symptoms** who wants to get tested for COVID-19. People **with symptoms** should call their doctors.
 - ▣ **Where:** Burlington and Winooski
 - ▣ **How:** Register <https://humanresources.vermont.gov/burlington> (BTV) or <https://humanresources.vermont.gov/winooski>
 - ▣ **Language help** available for registration: call 802-503-5402 or 802-355-0795.
 - ▣ Interpreters available at select Burlington & all Winooski events.

DVHA Update

- **COVID-19 Special Enrollment Period (SEP) extended until August 14, 2020** (previously set to expire 6/15/20)
 - ▣ Current: customers may choose effective date of either 6/1 or 7/1
 - ▣ Starting June 16 (1st day of extension) to July 15, customers may choose either 7/1 or 8/1
 - ▣ Starting July 16 to August 14, customers may choose either 8/1 or 9/1
 - ▣ Other parameters unchanged: applicants must be uninsured (self-attestation); current enrollees are not permitted to change plans under this SEP; uninsured households previously terminated for non-payment in 2020 may re-enroll with full payment of the previous balance

Today's Media Briefing



Governor Scott:

- **March 13:** declared State of Emergency (SOE), followed by Stay Home/Stay Safe order and expanded restrictions.
- Now slowly loosening restrictions and taking steps to reopen the economy (all sectors have had some activities reopened)
- Metrics all positive (outbreak exception): still have ~130K active cases within 5-hour drive of VT borders.
- **Today:** outdoor lodging (campgrounds) open to 100% capacity
- **SOE extended to July 15** = “vehicle to apply/lift restrictions”

Today's Media Briefing



VDH Commissioner Levine

- Winooski/BTV/Chittenden Co. outbreak update:
 - ▣ Contacts 78 (about same as # of cases)
- Commissioner provided extensive review of test sensitivity, specificity, positive & negative predictive value.
- **Serology Work Group** (met multiple times past few weeks)
 - ▣ Tests: FDA has recognized deficits of many current tests; tightening regulatory authority.
 - ▣ Work Group identified 4 platforms with high sensitivity & specificity.
- NOT advocating use of serologic testing for return to work, infection control, individual clinical decisions. **Would consider** (limited) use as part of epidemiologic study (e.g., CDC, NIH, academic study).

Safe & Healthy Schools Guidance Updates

- Process included further input from medical colleagues on work group: consensus was that **facial coverings should be required of all students** (with the caveats already included in the guidance: developmental, medical, behavioral).
- Recommendation made (& agreed to by) VDH Commissioner Levine. Agency of Education Secretary French also agreed.
- Guidance edited to reflect this decision; **final guidance expected today or tomorrow.**
- Also revisiting aspects of childcare/summer program guidance; expect decisions/edits later this week.



Vermont K – 12 Immunization Coverage Rates

- School immunization data: >95% of Vermont students from kindergarten to 12th grade have all their required vaccines.
- Schools required to report vaccination rates by January 1 each year. Rates vary from high levels of coverage to much lower rates.
- VDH data: 77% of schools (representing 89% of Vermont students) meet the 95% immunization rate needed for community immunity against measles. Ninety-five schools had a MMR (Measles, Mumps and Rubella) vaccination rate of less than the 95% immunization rate.
