# VDH Updates – Immunization Registry Improvements

- Vermont IMR (7/27/20): new tool via web service for forecasting.
- Provides clinical decision support for immunization; supports all routinely administered vaccine groups from birth-adulthood.
- □ Based on the ACIP (CDC) schedule
- □ Provides the clinician with 3 critical pieces of information:
  - Assessment of what has already been given.
  - Recommendations for what vaccines are due today.
  - Conditional Recommendations for which vaccine might be called for if the patient has special health conditions.
- □ Corrects shortcomings of previous forecaster (e.g., flu & HPV).
  - Provides specific reasons why a previously administered dose may be invalid, and adds forecasting for adult patients. When a vaccine for Covid-19 becomes available, we expect to be able to quick avail ourselves of vaccine scheduling guidance through this tool.

IMR How To: Using the New Forecaster July 2020


It is one tring to know which immunizations a person has received, and quite another to know what other immunizations are called for, and when the next dose is due. We are happy to announce the Vermont Immunization Registry (IMR) has implemented a new forecaster that will help us to quickly incorporate new vaccine schedule recommendations issued by the CDC's Advisory Committee on Immunization Practices (ACIP). Enhanced vaccine clinical decision support via the immunization Calculation Engine webservice is now available in the Vermont immunization Registry.

Vermont's new forecaster uses the Immunization Calculation

Engine (ICE) webservice – a state-of-the-art open-source software system that provides clinical decision support for immunization. The forecaster supports all routinely administered vaccine groups, including the child, teen, and now even adult immunization schedules. It provides clinicians with guidance for recommended immunizations as well as conditionally recommended doses for people with health conditions that might call for additional protection.

#### Typical Immunization Records Look Like This

This is the Immunizations Grid in the IMR. It is clear what vaccines have been administered and when. But what vaccines might be due today? And, have the previously administered doses been given in line with the schedule guidance?





# Today's Media Briefing

#### Governor Scott:

- VT trends continue to hold steady/support move toward school reopening in fall. Outbreaks may be spreading back toward us.
- With low #s, waited to implement mask mandate continued to focus on education.
- But looking at situation in southern & western U.S., visitors & Vermonters moving inside, "need to act now to protect our gains."
- Signed order today, effective August 1, 2020, to strengthen mask mandates. Will be required of all (over age 2 y.o.) in indoor public places & outdoors when physical distancing not possible.







# Today's Media Briefing (cont'd.)

Governor Scott: mask mandate (cont'd.)

- Exceptions: eating drinking, vigorous exercise, any child or adult w/condition that precludes wearing.
- Difficult to enforce will <u>not</u> require documentation of health condition (avoid violation of health care rights).
- Businesses required to inform customers can refuse to serve individuals not wearing masks





Governor Scott: mask mandate (cont'd.)

- Still worried that mandate will create conflicts take a moment to speak to both sides. Acknowledge that some can't wear – and times when mask not necessary under this mandate.
- "For those who've resisted: I'm asking you to look at the real data realize the science is real."
- CDC says surge in Sun Belt could be controlled if citizens disciplined enough to follow mitigation strategies.
- □ "Please help . . not b/c it's mandated, but b/c it's the right thing to do."
- "For those already wearing masks & concerned re: those who aren't please give them the benefit of the doubt."









Commissioner Pieciak – VT modeling:

- Yesterday: 4m. reported cases in U.S. "staggering number and pace." Rate of rise: 99 days to 1m. (when testing very limited); "alarming pace" to reach to 2m. in 43d. Reached 3m. in another 28d. Most recently reached 4m. in just 15 days.
- Daily growth rates across U.S. census regions South & West with high daily numbers (some areas w/improvement)
- U.S. 7-day rolling average highest ever, w/incr. hosps. & deaths. (yesterday 3<sup>rd</sup> consecutive day with >1100 deaths).
- □ VT lowest per capita past 7d.; regional (NE) week over week just >8%.





# Today's Media Briefing (cont'd.)

Commissioner Pieciak (cont'd.)

- Regional forecast: 4 models project growth in coming weeks
- □ Vermont data/metrics:
  - Cases: 52 new this week (vs. 55 previous week)
  - Syndromic surveillance flat/well below 4% guardrail
  - Viral growth rate ~0.5%
  - Test positivity rate rolling average <1% this week (one of lowest in U.S.)</p>
  - Hospital/critical care bed has been ~30% buffer; slightly over this week, but w/other metrics performing well, "not concerning." No COVID patients in ICU at present.

□ Travel map changes reflect case growth across U.S. & in Northeast.







# Today's Media Briefing (cont'd.)

#### **Commissioner Levine**

- Vermont fortunate w/low levels of virus, but not "none." No new news about outbreaks/non-outbreaks; "containment working."
- □ Possible explanations for VT's lowest pos. rate, new cases, no recent d.
  - Vermonters' cooperation & compliance; prioritization of health (natl. rankings)
  - Vermonters' belief in policy of protecting the most vulnerable
  - Vermont did not reopen until sufficient level of virus suppression statewide
  - Phased/gradual reopening meant less active cases/hosps./serious illness
- Mask decision not taken lightly but government takes responsibility to protect citizens; PH uses data/science to make recommendations.
- Mask mandate reasonable esp. given increased "red zones" around us.

# VDH Updates: calling all Tweetiatricians!

- VDH leading Governor's new statewide #MasksOnVT campaign
  - Encourages Vermonters to wear masks to reduce the spread of COVID-19.
- □ Goal: collective impact to normalize/sustain mask wearing in VT.
- One-stop digital toolkit to assist state agencies, departments and partners in sharing message: use or adapt campaign materials as appropriate for audience.
  - Sample social media posts and content, sample newsletter blurbs or articles, key talking points and posters. Use as is OR fully customizable for more advanced users.



#### AAP/Other Updates

- AAP Daily Briefing: article on how lack of pediatric data is complicating school reopening plans.
- AAP-VT: press release in development to encourage prioritization of in person attendance for preschool through grade 5 and for all students with special needs.
  - Anticipate release Monday, 7/27/20.
  - Please continue discussions with their schools/districts about how models can evolve over time and be re-evaluated even if initial plans have been released.
- CDC Updated Guidance: Preparing K-12 School Administrators for a Safe Return to School in Fall 2020 (updated July 23, 2020)

- Clarification re: when to close
- Challenges with seating on buses
- □ Physical distancing (implementation "6 ft.")
- □ Interns/Learners

#### AHS Secretary Mike Smith:

□ Opened Friday, July 17, 2020 (application, FAQs)



- Who: VT-based health care/human service (*billing*) providers operating on/before February 1, 2020
- When: Cycle One online application process open until August 15, 2020, to cover lost revenue/expenses from 3/1/20-6/15/20. Cycle Two: applications starting in October to cover losses from 6/16/20-9/30/20.
- What: submit 2019 & 2020 revenue information, COVID-19 related expenses, data on any financial relief received and org. tax info.
