**EleCare** – Abbott is restarting EleCare® production, with initial product release being on or about June 20. Working to quickly refill hospitals, retailers, distributors, and HMEs.

Abbott is offering to direct ship a case (6 cans) of EleCare to families needing this amino acid-based formula. Should arrive in 48 hrs.

- Products:
  - Total Comfort
  - Neosure
- Unclear of timeline but approx. 686,530 cans to begin arriving in US
- Hearing it may only be online availability, with "some" held for WIC
- Kendamil and Bubs still anticipating at Target initially, will keep you updated when they will be available for WIC
